Forms will be processed by GHF and submitted to the Texas Historical Commission for final review and appeals. You will be notified by mail of exemption eligibility within 60 days. After the completed form is returned, please send a copy of your approved eligibility form to your insurance agent.

You will need a **separate** exemption for each building 50 years old or older on your property.
